"One who injures another is liable to pay compensation for that injury due to five types of indemnity: He must pay for damage, for pain, for medical costs, for loss of livelihood, and for humiliation" (Mishnah Baba Kamma 83b (8:1)). These five categories of restitution compose fundamental Jewish law - but how are they meant to be interpreted, and how can these interpretations develop as civilizations progress and the world around us changes? How do the complexities of individual experience influence the assessment of the damages? Do these payments stand alone, or can they be interpreted as one? In this endeavor into the minds of the ancient rabbis, award winning authors Tal Pemstein and Judith Epstein delve into the interconnected nature of the five damages and attempt to untangle the roots that unite them.
