Instructions for Hebrew College's 2024-2025 Application for Financial Aid

If you do not need financial aid, you do NOT need to complete this form.

Hebrew College's Financial Aid Office is eager to help you develop plans to pay for and/or finance your educational and living expenses. Confidentiality: All financial aid information supplied by you is considered confidential and will not be made available to any individual or entity not directly connected with granting financial aid at Hebrew College.

Types of aid: Aid may be awarded by the College in the form of multi-year fellowships, scholarships, and/or need-based grants. Financial aid awarded by the College will be applied towards your tuition costs only. Federal loans, if you qualify, may be used towards tuition, registration fees, and other costs, such as living expenses, that may be affiliated with your enrollment in one of our programs.

Eligibility: Financial aid is available to matriculated students in degree and/or ordination programs only. Aid may be awarded to newly accepted candidates in most of Hebrew College's degree programs, and to continuing degree candidates in good academic standing. **Students must re-apply for aid each academic year.**

To qualify for financial aid, you must:

- Be accepted into one of Hebrew College's degree and/or ordination programs.
- Enroll at least half-time in both the fall and spring semesters, and/or optional summer term. (If you are in your final year of enrollment before completing your degree program and you enroll less than half-time, you may still qualify for federal aid. Please contact the Financial Aid Office.)
- Be in good academic standing within your program of study.
- Have no outstanding tuition and fees owed to Hebrew College from the current or previous semesters.
- Meet federal guidelines to receive federal aid.

FAFSA: In addition to completing the form below, applicants and returning students must complete a Free Application for Federal Student Aid (FAFSA) in order to be considered for federal loans. We cannot apply for federal loans on your behalf without a completed FAFSA to supplement this form.

- Exceptions:
 - o Continuing students receiving a multi-year fellowship are asked to complete a FAFSA **only** if they will be requesting federal Direct Student Loans.
 - o Non-U.S. citizens cannot complete the FAFSA.

• Information needed for this year's FAFSA is based on your **2022** federal income taxes, which would be filed by April 15, 2023.

- The FAFSA website will automatically send a summary of the completed report, based on the information you provided, to you and to the College.
- Please note that we will not process your FAFSA until after we receive your Hebrew College "Application for Financial Aid" below, **and** you are accepted into one of our degree programs.

Current vs. Prior-Prior Year: While this year's FAFSA should be completed based on your 2022 income, assets, and family circumstances ("prior-prior year"), Hebrew College's accompanying 2024-2025 Application for Financial Aid should be completed based on your **current** income, assets, and family circumstances.

Hebrew College is keenly aware that your current financial circumstances may be very different from what you were experiencing in the past year. If this is the case, we ask that you attach a statement outlining the changes that have occurred (e.g., "My spouse ended their employment on 5/1/23 due to ...").

Applicants for Admission: If you are applying for admission into one of Hebrew College's degree programs, **you are encouraged, but not required,** to submit the accompanying Application for Financial Aid and your FAFSA (non-U.S. citizens/noreign students cannot complete the FAFSA but should still complete this form) when you apply for admission.

- This form may be completed and submitted as early as December 1, 2023. The sooner we receive your paperwork, the sooner you will receive your financial aid notification.
- The deadline for applicants to ordination programs to submit your "Application for Financial Aid" and your FAFSA is February 1, 2024.
- If you are accepted and you defer your enrollment, a new financial aid application will be required by March 1 prior to the planned start of your program.

Continuing Matriculated Students: If you are a continuing Hebrew College student receiving aid, you **must** submit a new Hebrew College Application for Financial Aid **and** your FAFSA by March 1 each year. Financial aid applications received after this deadline will be considered, but the amount of institutional aid available may be limited.

Applicants who are U.S. citizens or eligible non-citizens may complete the FAFSA. Non-U.S. citizens, see below.

- Federal income taxes must be completed and filed: The tax information on which the 2024-2025 FAFSA application is based was due to be filed by April 15, 2023—this is your tax return for the 2022 fiscal year. Please note that if your FAFSA application is selected for verification, you will be required to submit an official IRS tax transcript of your 2022 taxes during the verification process. No aid can be disbursed until the verification process is completed.
- For those not required to file federal income taxes: If you are a non-tax filer, we ask that you submit a signed statement* indicating that you have not filed and that you are not required to file federal income taxes. You must also provide W-2 or 1099 forms to verify your income for the year. * *This statement can be a typed letter, or, if you prefer, you may complete the form and check item seven at irs.gov/pub/irs-pdf/f4506t.pdf*.

Non-U.S. citizens/Foreign students must supply income and visa information. A foreign student is a non-eligible noncitizen if they are or will be in the U.S. on a visa, including the F-1 Student Visa issued through the school.

- You might qualify for Hebrew College scholarship/fellowships/need-based grants.
- You are still required to supply income information even if your income is from a country other than the U.S. All information must be supplied in writing and in English showing U.S. dollar amounts.
- As a non-eligible foreign student, you cannot complete the FAFSA.
- If you are in the U.S. on a visa other than an F-1 Student Visa received through Hebrew College, you must provide a copy of your current passport and visa.

If there is any other relevant information that would help us to understand your needs, please attach a typed statement to the application that explains the unique circumstances we should take into consideration.

NEXT STEPS for the Hebrew College Application for Financial Aid:

If you are ONLY applying for fellowships, scholarships, and merit awards, and do NOT wish to be considered for need-based aid, COMPLETE PAGE 1 and simply SIGN PAGE 2 of this application.

If you wish to be considered for need-based aid AND fellowships, scholarships, and merit awards, COMPLETE BOTH PAGE 1 and PAGE 2 and SIGN PAGE 2.

REMINDER: If you do not need financial aid or merit awards, you do NOT need to fill out this form.

If you would prefer not to submit Hebrew College's Application for Financial Aid via an email attachment that includes your private information, please ask the Financial Aid Office to send you this form using DocuSign.

What happens AFTER you submit the Hebrew College Application for Financial Aid and your FAFSA (if applicable):

Type of Aid	Next Steps
Hebrew College scholarships, fellowships, and/or other merit awards or need-based grants	 The program dean or director, the Director of Student Services, and the Director of Admissions (for new students) will meet to determine whether you qualify for any awards and what the amount would be. The Financial Aid Coordinator will notify you about any award that has been selected for you. If you would like to request additional financial aid to cover your expenses, please outline your needs in a message to the Financial Aid Coordinator and we will let you know if additional funding is available.
Federal student loans	 If the Department of Education, upon receiving your FAFSA, approves your eligibility to receive new loans, our Financial Aid Coordinator will send you a Loan Request Form to complete which authorizes us to initiate the loan process with the government. Once we receive the loan funds from the government, we will notify you that the funds have been applied to your account. If there is a loan refund or tuition balance, the Student Services Coordinator will contact you to confirm the next steps.
