- Daniel Klein
 - Lifelong connection to Hebrew College, through both Camp Yavneh and Prozdor. His family has also been connected. He is also a Rabbinical School Alum.

Jane Kanarek

- Personal background: grew up in Newton Centre; came to Hebrew College in 2005 part-time, while working on dissertation at University of Chicago. Being at Hebrew College gave Jane the chance to teach the text she loved in its original language. Discovered a love of teaching Rabbinical students. Academy/Religious life speak to each other very deeply. Deeply poetic religious language. Excited to continue to foster excellence in teaching and mentor junior faculty; support learning needs of students.

- Keith Dropkin gives March 31 financial report
 - Working hard building the FY25 budget
 - Contributions in great shape; grant revenue is the shortfall 400k short of where we expected to be
 - Beyond budget revenue of 300k offsetting what would otherwise be savings
 - Net tuition trailing budget by 121k

David Hoffman

- Stronger arm to grants rather than just believing they are going to "come in"
- o Interfund Borrowing: In 2008 HC was short on operating funds; the Board borrowed from the Endowment (3.1 million). Was due to be paid back in 10 years; 16 years later and not much has been paid back.
