I.

OVERVIEW

IV.

Procedures to Notify Student Body on Criminal Statistics and Emergencies

In cooperation with the Newton Police Department, Hebrew College is notified of all crimes reported on campus and in our surrounding area to be included in our safety report, compiled and released annually. A copy of the Safety Report can be viewed on our website. The building is equipped with smoke detectors and fire alarms in case there is a fire. In the event of a lockdown, 2-way radios have been distributed to key staff members. Portable silent panic buttons have been distributed to key staff members.

V.

Campus Access

All entrances to the campus are locked at all times and can only be opened through the use of an approved access fob, issued to all students, faculty and staff. In the event that an access fob is lost or stolen, report the issue immediately to Jimmy Comeau, our IT Help Desk technician, at jcomeau@hebrewcollege.edu, so that the access card clearance can be terminated and a new access fob can be issued.

VI.

Drug and Alcohol Policy

As stated in the Academic Catalogue, “Hebrew College provides a drug-free, healthful and safe campus. To meet this goal, the College expects you to attend classes in a mental and physical condition that enables you to perform in a competent manner. The College’s general policies provide that the campus and school activities are not a sanctuary from federal, state, and local laws. The policies prohibit the unlawful use, possession, sale, distribution, or manufacture of controlled substances or alcohol on school property or as part of school activities. While on Hebrew College premises or while conducting College-related activities off Hebrew College premises, you may not use, possess, distribute or sell alcohol or drugs, or be under the influence of alcohol or illegal drugs. The College permits the legal use of prescribed drugs only if they do not impair your ability to perform effectively and safely without endangering others. If you violate this policy, it may lead to disciplinary action, up to and including immediate disciplinary procedures and/or criminal prosecution under state and federal laws. Additionally, you may be required to participate in a substance abuse rehabilitation or treatment program. VII.

Statement of Policy Regarding Dating Violence, Domestic Violence, Sexual Assault and Stalking

A commitment to a harassment free environment is something that the faculty and staff take incredibly seriously within the Hebrew College community. To illustrate this, copied here in full is the section of the Academic Catalogue dealing with Sexual Harassment and Title IX policies.

It is the intent of the Hebrew College Sexual Misconduct Policy that all members of the Hebrew College community will learn, live, and/or work in an environment free from sexual misconduct. The College seeks to foster a safe environment through ongoing education, a clear and consistently upheld sexual misconduct policy, and fair and equitable investigation and grievance procedures.

The College expects members of our community to respect themselves and one another, contribute to the safety and security of our community, and encourage one another to act as active bystanders to prevent, lessen, and curb sexual misconduct.

Creating a safe campus environment is the responsibility of all Community members. Sexual assault, sexual harassment, dating violence, domestic violence, stalking, and all forms of discrimination relating to one's sex or gender identity violate the rights and dignity of those subjected to the prohibited conduct. When any member of our community (student, faculty, staff, trustee, friend, vendor, or visitor) engages in sexual misconduct, that person exhibits a fundamental failure to act with integrity and to recognize and respect the intrinsic worth of another.

Acts of sexual misconduct are contrary to the College's educational mission and values and will not be tolerated.

This policy does not apply to an incident of sexual misconduct between employees. Such situations will be referred to the College's Director of Human Resources. Situations involving an employee and a student will, however, be managed by the Director of Human Resources and the Title IX Team.

All Hebrew College community members are responsible for their actions and behavior on- and off-campus and have a responsibility to adhere to College policies and all applicable laws (local, state, and Federal). Any individual may report breaches to the Sexual Misconduct policy and, if determined that a sexual misconduct violation has occurred, the College will hold those individuals accountable for their behaviors.

IX.

Statement of Policy on Emergency Procedures

In the event of an emergency evacuation, maps with the closest possible exit are posted by doorways throughout the building. To build preparedness around emergency evacuations, Hebrew College holds evacuation drills once a semester to ensure everyone knows how to exit the building as quickly as possible.

The building is equipped with smoke detectors and fire alarms in case there is a need to evacuate. In the event of a lockdown, 2-way radios have been distributed to key staff members. Other portable silent panic buttons have been distributed to key staff members.

All emergency alerts are supervised by Sara Brown, Sr. Director of Operations and Finance Resources, and Sharon Anisfeld, President, with assistance from other key staff members who have been trained to handle these situations. They determine the wording and nature of the alerts, who will need to receive the alerts that are set out and disseminating the emergency situation alert to the local authorities and larger community.

The Emergency Response system will be tested at least once per calendar year. The testing may be announced or unannounced depending on what information is needed from the test.

X.

Timely Warnings of Crime and Emergency Notification

All emergency notifications described above will be delivered in a timely and effective manner that ensures all receiving the message will be given enough time as possible to react, adjust, and plan accordingly.

In addition to emergency notifications, Hebrew College will also provide timely notifications on crimes, including criminal homicide, sex offenses, robbery, aggravated assault, burglary, motor vehicle theft, arson and other offenses which lead to arrest to aid in the prevention of similar crimes. These notifications will be confidential and withhold the names and identification of victims, in accordance with the Violence Against Women Act of 1994. These notifications do not include crimes reported to a pastoral or professional counselor.

In the event of an immediate threat to the health and safety of students or employees on campus, Hebrew College will follow our emergency notification procedures and is not required to issue an additional notification in a timely manner. However, Hebrew College will provide updates to the situation for the community as needed.
